QUALIFICATIONS

For post at Sr. No. 1

- (A) i) A Master's Degree in Science/Humanities/Arts with 50% marks (or an equivalent grade in a point scale wherever grading system is followed).
- ii) M.Ed. with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and must have cleared the National Eligibility Test (NET) for lecturers conducted by the UGC or similar test accredited by the UGC.
- iii) However, candidates, who are or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations, 2009, as incorporated in the relevant Goa University ordinance shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.

OR

- (B) (i) M.A. in Education with 55% marks (or an equivalent grade in a point scale wherever grading System is followed).
- ii) B.Ed. with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed), and must have cleared the National Eligibility Test (NET) for lecturers conducted by the UGC or similar test accredited by the UGC.
- iii) However candidates who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations, 2009, as incorporated in the relevant Goa University Ordinance shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.

- (C) 1. For Post No. 1 (i) The appointment will be purely on Child Care Leave Vacancy till 31-03-2026 for the Academic year 2025-26.
(ii) The appointment will be purely on Lien Vacancy till the end of Academic year 2025-26.

For post at Sr. No. 2 & 5

- i) A Master's Degree in subject with 50% marks (or an equivalent grade in a point scale wherever grading system is followed),

- iv) For Post No. 2 the appoint will be purely on Contract Basis for vacancy against deputation for the academic year 2025-26.
- v) For post No. 5 the appointment will be purely on Maternity Leave vacancy from 10/04/2025 to 06/10/2025 for the Academic year 2025-26.

For post at Sr. No.3

- (A)** (i) A Master's Degree with at least 55% marks (or equivalent grade in a point Scale wherever the grading system is followed) in the relevant subject or an equivalent degree from an Indian / Foreign university. (Music/Dance/Theatre Arts with 55% for Performing Arts)
- a) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.
- b) Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Statutes of the Institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/College/Institutions subject to the fulfilment of the following conditions:-
- a) Ph.D. degree has been awarded to the candidate in a regular mode
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate had been conducted;
- d) The candidate has published two research papers from his/ her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two research papers based on his/her Ph.D. work in conferences/seminars supported/funded/sponsored by the UGC/AICTE/ICSSR or any other similar agency.

Note 1: The fulfilment of these conditions is to be certified by the Vice Chancellor or the Dean (Academic Affairs) of the University concerned.

Note 2: The clearance of NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC (like SET).

OR

- B)** A traditional or a professional artist with highly commendable professional achievement in the subject concerned having a Bachelor's degree, who has:
- i) Studied under a noted /reputed traditional Master(s)/Artist(s)
- ii) Has been 'A' grade artist of AIR/Doordarshan;
- iii) Has the ability to explain, with logical reasoning the subject concerned; and
- iv) Has adequate knowledge to teach theory with illustrations in the discipline concerned.

For post at Sr. No. 4

- (i) A Master’s Degree in Physical Education and sports or Master’s Degree in Sports Science with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) with a consistently good academic record.
- (ii) Record of having represented the University/College at the Inter-University/Inter-collegiate competitions or the state and/or National Championships.
- (iii) Passed the physical fitness test.
- (iv) Qualifying in the national level test conducted for the purpose by the UGC or any other agency approved by the UGC.
